# From our Chairman

This year is notable in keeping up a constant stream of changes in the Seton Villa community, and some significant achievements as you will read.

The Daughters of Charity have reorganised their management structures in Australia. The Board does not expect that this will make any significant difference to Seton Villa or how we practically interact with the local Trustee.

In the past month, as part of the property redevelopment program, Seton Villa has been gifted the houses in which our residents live. Prior to this handover Seton Villa was using the properties, owned by the Daughters of Charity, under specific arrangements. Achieving this handover was a long process (permission was required from the Holy See in Rome) and we would like to thank the perseverance and tenacity of the Trustees in achieving this outcome. Owning our properties provides us with increased flexibility and will enable us to better interact with government and other agencies.

I am also happy to report that we are about to complete the first two new homes. I have seen both properties and would like to congratulate Peter and his team (including the builder) on a superlative result. These are a real step-up for Seton Villa and I can't wait for our residents to finally move in. Peter has more details on page 2.

Finally, as we look to our future, it is clear that we need to build our capacity at systematically raising funds for projects. As I have previously stated, this extensive property redevelopment is only possible due to the generosity of past donors and bequests. Future projects need to be funded by new donations so to this end, we have started a working group to determine what kind of fundraising is appropriate and achievable for Seton Villa. We would welcome the inclusion of parents/carers to this working group. If you are interested, please let Peter know.

### From the Trustees of the Daughters of Charity



In recent years, the Daughters of Charity in Australia have reflected on how to continue the life and ministry of the community in the face of aging and diminishing numbers. A decision was made to integrate with the Daughters in Great Britain. On the 11th March in London a new province was formed – the Province of Rosalie Rendu. Blessed Rosalie was a pioneering Daughter who organised care for the poor in the slums of 19th century Paris.

For the Daughters, this change has resulted in new opportunities and support as we link closely with the Sisters in Great Britain. The Provincial, Sr Ellen Flynn DC, resides in Mill Hill London and communicates well via Zoom and emails. She has visited many times and truly values all the ministries in Australia. Locally, the Daughters are supported by a Coordinator (Sr Celine Quadros), an Advisory Group, as well as four Trustees who are responsible for the Works, finance and property.

This Integration provides some infrastructure support for the Trustees and there will be flow-on benefit for the Works including Seton Villa. In other ways nothing has changed. The local Daughters will continue their appointment of a Delegate, conduct the AGM, support the work and be a friend to the women, families and staff that are part of the community of Seton Villa.

#### "Building our Bright Future" Status Report

I am excited to announce that handover of our first two new Specialist Disability Accommodation (SDA) houses is imminent. Residents from Culloden Road and Tulip Street will receive the keys to their new homes from Academy Constructions at a small afternoon tea on Wednesday 18 November 2020.

Residents will move into the new accommodation at Jenny's Place (1 Keiley Street, Marsfield) and Rosalie's Place (54 Lavarack Street, Ryde). We are all extremely excited!! In line with COVID gathering restrictions, each house will celebrate a combined housewarming/Christmas event catered at home with their families, courtesy of funds being provided by the P&F Group.

A big thank you on their behalf! The other houses will also celebrate individually catered Christmas events with families either at home or at a restaurant - again with financial support from the P&F Group.

The bathroom fixtures, kitchens, blinds and landscaping have been the final pieces of the construction process as shown in the following pictures.

We also settle on **our newest acquisition at 91 Bridge Road**, **Ryde** on Monday 2 November 2020. The weatherboard cottage will be demolished and replaced with a new five-bedroom SDA certified home during 2021, similar in design to Rosalie's Place. Our current Tulip Street property will also be demolished at the same time with parallel construction of a new four-bedroom SDA certified home on the site. We are yet to confirm which residents will move into these two new houses.
