
## From our CEO continued

### **COVID-19 Update**

**Thankfully, the ongoing impact of COVID on Seton Villa has been small**. Almost all residents have now received their 2nd Pfizer booster and as I write, we remain COVID free in the houses. We will continue to focus on our COVID prevention strategies to keep everybody safe and well.

#### **NDIS Mid-term Certification Audit**

Our NDIS Mid-term Certification Audit was undertaken on 25 and 26 August 2022, and our audit team were very excited to see the new houses (albeit remotely) and talk to selected residents about their experience of moving into their new SDA homes. This 'mini' audit focussed on Governance and Operational Management at Seton Villa, including 2 new NDIS Practice Standards on Mealtime Management and Individual Disaster and Emergency Management Plans. To the right is a photo of our new 'Disaster and Emergency Management Kit' that contains essential information and support items for the residents of each house that can be deployed immediately in the event of an emergency evacuation etc.

The initial feedback from the audit team has been extremely positive.



# Strategic Planning for 2023-25

Now that we can see the finishing line for our Asset Redevelopment Project, the Seton Villa Board engaged in a strategic planning workshop on 10 August 2022 to begin to explore strategic directions for Seton Villa over the next three years.
