

NDIS Independent Review

In mid-October 2022, the disability sector welcomed the announcement by the Hon Bill Shorten, Minister for the NDIS, of the Terms of Reference for a review into the NDIS.

The Independent Review – comprising Prof Bruce Bonyhady AM (co-chair), Ms Lisa Paul AO PSM (co-chair), Mr Kevin Cocks AM, Ms Judy Brewer AO, Dr Stephen P King, Mr Dougie Herd and Ms Kirsten Deane OAM – will report directly to Disability Reform Ministers. It will be supported by a Secretariat in the Department of the Prime Minister and Cabinet.

Dr Bonyhady will lead Part 1 of the Review: Design, operation and sustainability of the NDIS. This will cover the participant experience and journey; the effectiveness and fiscal sustainability of the NDIS; the roles and interactions between the NDIA, NDIS Commission and the DSS; Scheme efficiencies; and the interactions between the NDIS and other systems and services.

Ms Paul will lead Part 2 of the Review: Building a more responsive and supportive market and workforce. This will cover market stewardship; innovation and better outcomes for participants; thin markets; workforce; accommodation; consumer information and the role of intermediaries; the Quality and Safeguards Framework; the regulatory functions for providers; and improving compliance monitoring and reporting, including the detection of fraud.

At a recent Thought Leadership Roundtable, the co-chairs of the Review strongly encouraged participants, families and providers to submit an account of their experiences and concerns with the scheme – in any format and of any size. Strategic Planning for 2023-25

On 18 November 2022, the Board Chair and I shared the emerging strategic directions for Seton Villa with the Daughters of Charity Trustees at their Annual General Meeting. It was delightful to have Sr Ellen Flynn, Provincial for the Province of Rosalie Rendu, fly out from the UK to be physically present for the occasion. Our desire for future growth was embraced, with further thought to be given to financing models for new SDA developments prior to final approval. The NDIS SDA pricing review that is currently underway will be a key factor in determining the financial sustainability of SDA for investors moving forward. This report is due for publication in April 2023, and I will keep you all apprised of developments.
